Explanatory Note

This Amendment No. 1 to the Schedule 13G originally filed on September 10, 2021 (the "Original Schedule 13G") is being filed to correct an inadvertent error in the reported percentage ownership of the Reporting Persons. The ownership of the Reporting Persons has been and remains as of the date of this Amendment No. 1 less than 5% of the outstanding Class B ordinary shares of the Issuer (as reported in Exhibit 99.1 to the Issuer's Current Report on Form 6-K filed with the Securities and Exchange Commission on August 27, 2021). The number of Class B ordinary shares of the Issuer deemed beneficially owned by the Reporting Persons has not changed since the filing of the Original Schedule 13G. This Amendment No. 1 constitutes an exit filing for the Reporting Persons.
